## **Chairperson**

Ms. Echols, Chair, called the meeting to order at 9:10 a.m.

## **Conflict of Interest**

Ms. Echols called for any conflicts of interest with the meeting agenda. There were no conflicts or potential conflicts.

# Legal Services Committee

Board members reviewed an email dated January 16, 2023 from Mr. Wilkins to Mr. Larue regarding scope of practice.

## Response to Beth Sanchez regarding medication policy; follow-up email from Nancy Winkler

Board members reviewed an email dated January 16, 2023 from Mr. Wilkins to Ms. Sanchez regarding medication policy. Board members also reviewed an email dated January 22, 2023 from Nancy Winkler as a follow-up to the

response to Ms. Sanchez. The Board does not agree it is the OT/OTA's responsibility to determine drug interactions however, if the drug interactions are automatically determined by the company's EMR system and all the OT/OTA does is document the EMR system found a drug interaction, then the OT/OTA can document that the EMR system found a drug interaction. The OT/OTA cannot "determine drug interactions" through assessment, diagnosis or judgment but can notify the MD and clinical manager about the EMR system determinations.

# **Response to Kelly Rutherford regarding supervision**

Board members reviewed an email dated January 19, 2023 from Mr. Wilkins to Ms. Rutherford regarding supervision.

## NEW BUSINESS

## Email from Daniel Thompson regarding verbal medication orders

Board members reviewed an email dated January 25, 2023 from Mr. Thompson regarding verbal medication orders and agreed an OT practitioner cannot take verbal medication orders. The Board also agreed an OT practitioner may not "assess" medications the patient is taking. While an OT practitioner may be trained to report and document the medications the patient is taking, the OT practitioner is not trained to "assess" the medications the patient is taking, both prescription and over-the-counter, as that would be in the scope of practice of medicine and nursing. An OT practitioner can document and report all medications the patient is currently using. However, an OT practitioner cannot identify any potential adverse effects and drug reactions, including ineffective drug therapy, significant side effects, significant drug interactions, duplicate drug therapy, and noncompliance with drug therapy as those functions are within the scope of practice of OT in North Carolina.
